## About the Authors

**Philip Brey** is associate professor and vice chair of the department of philosophy at the University of Twente, Enschede, the Netherlands. He received his Ph.D. at the University of California, San Diego. He has published widely in the philosophy of technology, with a special emphasis on information and communication technology (ICT). He has been investigating how ICT artifacts and systems can, through their design and embedding in a sociotechnical context, come to function as agents that bring about changes in social and political arrangements and cultural practices, and he has also been studying the ethical dimensions of such changes.

**Paul N. Edwards** is associate professor of information at the University of Michigan, in Ann Arbor, where he chairs the Program on Science, Technology & Society. His research interests focus on the history, politics, and culture of information technology. Edwards is author of *The Closed World: Computers and the Politics of Discourse in Cold War America* (MIT Press, 1996) and co-editor, with Clark A. Miller, of *Changing the Atmosphere: Expert Knowledge and Environmental Governance* (MIT Press, 2001). He is currently completing a book about climate science and politics since 1950, tentatively titled *The World in a Machine: Computer Models, Data Networks, and Global Atmospheric Politics*.

**Andrew Feenberg** is professor of philosophy at San Diego State University. He is the author of *Alternative Modernity* (University of California Press, 1995), *Questioning Technology* (Routledge, 1999), and *Transforming Technology* (Oxford University Press, 2002). Feenberg is currently

doing research on the Internet and software development for online education under grants from the National Science Foundation and the Fund for the Improvement of Postsecondary Education.

**David Hess** is a professor in and chair of the science and technology studies department at Rensselaer Polytechnic Institute, Troy, New York. He is the author of ten books and edited volumes in anthropology and science and technology studies, including *Science and Technology in a Multicultural World* (Columbia, 1995) and *Science Studies: An Advanced Introduction* (NYU Press, 1997).

**Haider A. Khan** holds a permanent faculty position in the Graduate School of International Studies at the University of Denver, Colorado, and has held visiting positions in Tokyo University, Hitotsubashi University, Tilburg University, Liaoning University, University of Costa Rica, and Cornell University. His fields of specialization are economic theory and international and development economics. He has published four books and monographs as a single author, two books as a co-author, and more than thirty articles in professional journals. He was at the Asian Development Bank, Manila, and at the Asian Development Bank Institute, Tokyo, from 1997 to 1999. He will be a fellow at the Center for International Research on the Japanese Economy at the University of Tokyo in 2002.

**David Lyon** is professor of sociology at Queen's University in Kingston, Ontario. He has been researching the social aspects of communication and information technologies since the early 1980s. His books in the area include *The Information Society: Issues and Illusions* (Polity/Blackwell, 1988), *The Electronic Eye: The Rise of Surveillance Society* (Polity/Blackwell, 1994), *Computers, Surveillance and Privacy* (co-edited with Elia Zureik, Minnesota, 1996), and *Surveillance Society: Monitoring Everyday Life* (Open University Press, 2001). He is currently writing a book on the critique of cyberspace.

**Barbara L. Marshall** teaches sociology at Trent University in Peterborough, Ontario. She is the author of *Engendering Modernity: Feminism, Social Theory and Social Change* (Polity, 1994) and *Configuring Gender: Explorations in Theory and Politics* (Broadview, 2000), as well as various articles on feminism, social theory, and gender. She is continuing to

explore the historical and contemporary intersections of gender, sexuality, technology, and consumer culture, and in a joint project with Anne Witz is conducting an interrogation of the masculine ontology that underpins sociological theories of modernity.

**Thomas J. Misa** is associate professor of history at Illinois Institute of Technology, Chicago. He is the author of *A Nation of Steel: The Making of Modern America, 1865–1925* (Johns Hopkins University Press, 1995), which was awarded the Society for the History of Technology's Dexter Prize. His forthcoming interpretation of technology and culture since the Renaissance is tentatively entitled *Leonardo to the Internet*.

**Arthur P. J. Mol** is professor of environmental policy at Wageningen University, the Netherlands. He has published widely on industrial transformations, globalization, and ecological modernization.

**Junichi Murata** is a professor in the department of history and philosophy of science, University of Tokyo. His main research theme is phenomenological theory of knowledge; he has been working on the philosophy of perception and mind and the philosophy of science and technology. His main publications include *Perception and the Life-World* (University of Tokyo Press, 1995; in Japanese); and "Consciousness and the Mind-Body Problem" in *Cognition, Computation, Consciousness*, edited by M. Ito et al. (Oxford University Press, 1997).

**Arie Rip** is professor of philosophy at the University of Twente, Enschede, the Netherlands. He is a former secretary of the European Association for the Study of Science and Technology (1981–86) and past president of the Society for Social Studies of Science (1988–89). His research and publications focus on science and technology dynamics and science and technology policy analysis, including constructive technology assessment.

**Don Slater** is a reader in sociology at the London School of Economics. His research includes work in economic sociology and the relationship between culture and economy; consumer culture, objects, and technology; and comparative ethnographies of Internet use. Recent publications include *Consumer Culture and Modernity* (Polity, 1997); with Fran Tonkiss, *Market Society: Markets and Modern Social Theory* (Polity,

2000); and with Daniel Miller, *The Internet: An Ethnographic Approach* (Berg, 2000).

**Johan Schot** is professor of social history of technology at Eindhoven University of Technology and the University of Twente and scientific director of the Foundation for the History of Technology. He is the program leader of the national research program on the history of technology in the Netherlands in the twentieth century. He is co-founder (together with Kurt Fischer) of the Greening of Industry network and project leader of several European Union-funded international projects. He chairs (with Ruth Oldenziel) the European Science Foundation network, *Tensions of Europe: Technology in the Making of Twentieth Century Europe*. His research work and publications span the history of technology, science and technology studies, innovation and diffusion theory, constructive technology assessment, environmental management, and policy studies.
